GDPR – General Data Protection Regulation

New UK laws designed to protect your personal information come into effect on the 25th May 2018. These regulations require us, Hertford Art Society, to make all members aware of the Society's Privacy Policy and ask you to 'opt in' to receiving communications from us.

What constitutes Personal Data?

Any information related to a natural person or 'Data Subject' that can be used to directly or indirectly identify the person. It can be anything from a name, a photo, an email address, medical information, or bank details for instance.

Your details are held by the Membership Secretary and kept up to date, your information is provided to other officers of the committee for the normal running of the society. Individual's details are not passed on to others without the Member's consent. Also, under no circumstance would your information be passed to any other organisation/individual who may wish to use your details or information for their own purposes.

Your Rights

In addition to being informed by us of our GDPR policy, you may contact the Membership Secretary to view, correct, update, erase, restrict use or object to the use of your sensitive data.
